# Terms & Conditions

---

Bulgaria's Largest School-Level  
MUN Simulation

These Terms and Conditions govern participation in the **Galabov Model United Nations - "GALMUN 2026"**. By registering, attending, or otherwise participating in the conference, all Participants agree to abide by these Terms.

---

## 1. Registration & Payment

- 1.1 Registration must be completed through the official GALMUN 2026 application form;
  - 1.2 Participants are responsible for providing accurate personal and institutional details during registration;
  - 1.3 All Participants shall provide an express *Release of Liability Form* upon registration at the conference venue. In case the Participant is a minor, the form should be signed by a parent or legal guardian;
  - 1.4 Participation is only confirmed upon receipt of full payment of the conference fee by the specified deadline;
  - 1.5 Participants who have paid but later cannot participate are eligible for a full refund only if they inform the Organizing Team at least 25 days before the start of the event. Refund requests made less than 25 days before the event will not be accepted.
  - 1.6 If a Participant is unable to attend at short notice, a substitute can be named. A written agreement with the Secretary General is obligatory. There are no additional costs for the Participants.

## 2. Eligibility and Participation

- 2.1 Participants must be in the age group 14 – 25 years old. The Organizing Team reserves the right to verify eligibility and to deny participation to any applicant who does not meet the requirements;
- 2.2 Each Participant must attend all official sessions of GALMUN 2026, unless excused by the Secretary General;
- 2.3 Participants must adhere to the **Code of Conduct** (see Section 3).

### 3. Code of Conduct

- 3.1 All Participants must maintain respectful behavior at all times towards, but not limited to, the Secretary General, the Chairs, fellow Participants, staff and venue personnel;
- 3.2 Discrimination, harassment, intimidation, or offensive behavior of any kind will not be tolerated;
- 3.3 Participants must dress in **Western Business Attire** for all formal sessions. The Organizing Team reserves the right to determine whether attire is inappropriate and may ask Participants to leave the venue to change or, in cases of refusal, remove them from the event;
- 3.4 The use of alcohol, drugs, or any prohibited substances is strictly forbidden during the conference;
- 3.5 Participants are expected to represent their assigned Member State/Company/Organization responsibly and diplomatically.

### 4. Rules of Procedure

- 4.1 GALMUN 2026 will follow its official **Rules of Procedure**, distributed prior to the conference;
- 4.2 The decisions of the Secretary General and the Chairs are final and binding.
- 

### 5. Liability and Safety

- 5.1 Participation in GALMUN 2026 is at the Participant's own risk. The Organizing Team is not liable for personal injury, illness, loss, or damage to property;
- 5.2 In case of emergency, Participants must comply with instructions from the Organizing Team and venue staff.

## 6. Media and Intellectual Property

6.1 All study guides, conference materials and intellectual property distributed by GALMUN 2026 remain the property of the Organizing Team and may not be reproduced without permission.

## 7. Data Protection

- 7.1 Personal data collected during registration will be used **only** for organizational purposes.
- 7.2 Data will not be shared with third parties, except when required by law.
- 7.3 By registering, Participants consent to the storage and processing of their personal information in accordance with applicable laws.
- 

## 8. Disciplinary Measures

- 8.1 The Organizing Team reserves the right to revoke participation, without refund, from any Participant who violates the “Terms and Conditions”.
- 8.2 Serious breaches may result in removal from the conference and notification of the Participant’s school or institution.
- 

## 9. Amendments

- 9.1 The Organizing Team reserves the right to modify these Terms at any time.
- 9.2 Any changes will be communicated to Participants via the official GALMUN 2026 email.

## 10. Governing Law

These Terms are governed by the laws of the Republic of Bulgaria.
